Road Traffic Regulation Act 1984

NOTICE is hereby given that the KENT COUNTY COUNCIL, has made the above named Order, acting as the local traffic authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called 'the Act') and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act.

The effect of which would be the following:

- a. Introduce a Restricted Parking Zone no waiting and no loading Monday to Saturday between the hours of 10am and 11am and 2pm to 3pm except within signed bays at the following locations:
 - i. Whitecliffe Road, both sides, from the junction of Southfleet Road to the eastern boundary of 12 Forrest Shaw.
- b. Introduce Disabled Badge Holders Only, maximum stay 3 hours no return within 1 hour, at the following location:
 - i. Kent Road, Longfield east side, from a point 10 metres north west of its junction with Station Road in a north westerly direction for a distance of 14 metres.
- c. Introduce At Any time waiting restrictions to the following locations:
 - i. Mill Road, Hawley, northern side, from a point 15 metres west of the western kerb line of Hawley Road to the common boundary of Avlon and 1b Mill Road;
 - Castle Road, Swanscombe, both sides, from a point 5 metres west of the western kerb line of Castle Street to a point 5 metres east of the eastern kerb line of Castle Street;
 - iii. Castle Street, Swanscombe, both sides, from a point 5 metres north of the northern kerb line of Castle Road to a point 5 metres south of the Castle Road junction;
 - iv. St Vincents Avenue, Dartford, western side, from a point directly opposite 18 and 20 St Vincents Avenue to a point 5 metres north of the common boundary of 24 and 26 St Vincents Avenue;
 - v. Riverside Way, Dartford, south-eastern kerb line, from a point opposite unit K8 and K9 Riverside Way to a point 23 metres south east of that point to the entrance of Prospect House;
 - vi. Riverside Way, Dartford, northern side, from a point 88 metres west of the western kerb line of Riverside Way to a point 23 metres west of this point;
 - vii. Riverside Way, Dartford, southern side, from a point 88 metres west of the western kerb line of Riverside Way to a point 30 metres west of this point;

- viii. Riverside Way, Dartford, northern side, from a point 12 metres east of the southern arm of Riverside Way to a point 5 metres east;
- ix. Baker Crescent, Dartford, southern side, from a point 14 metres west of the western kerb line of Millers Close to a point 14 metres east of the eastern kerb line of Millers Close:
- x. Millers Close, Dartford, both sides, from the junction of Baker Crescent to a point opposite the common boundary of 1 Millers Close and 66 Baker Crescent.
- xi. Hayes Road, Greenhithe, south-eastern side, from a point opposite the common boundary of 3 and 5 Hayes Road to a point 30 metres southwest of that point.
- xii. Priory Gardens, Dartford, north eastern side, from a point opposite the common boundary of 3 and 4 Highview Terrace to the common boundary of 2 Priory Gardens and 4 Highview Terrace.
- d. Introduce At Any time loading restrictions to:
 - St Vincents Avenue, Dartford, western side, from a point directly opposite 18 and 20 St Vincents Avenue to a point 5 metres north of the common boundary of 24 and 26 St Vincents Avenue.

Road Traffic Regulation Act 1984

The Kent County Council acting as traffic authority hereby make the Order referred to above and as shown on the plans accompanying this document for the following reasons:-

Concerns have been raised regarding inconsiderate parking at various locations borough wide that can have a detrimental impact on the free flow of traffic and interfere with sightlines at junctions. Therefore, the introduction of restrictions are proposed to address the identified parking issues by:

- Removing an obstruction that can impact the free flow of traffic
- Improving sightlines at junctions for all road users
- For improving or preserving the amenities of the area through which the road runs

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2) of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following order:-

- 1. This Order shall come into operation on the 9th day of July 2021 and may be cited as 'The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2020 (Amendment No.4) Order 2021' ('this Order').
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, 'The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2020 (Amendment No.4) Order 2020' ('this Order') shall have effect as though:




St Vincent's Avenue, Dartford








